- ✓ The recipient/ applicant (whatever is most appropriate) must have a method for reporting back to the Giving Fund Team how the funds have been used/ to provide evidence the funds have been spent.
- ✓ Please make sure the beneficiary/ organisation know that you are applying to this fund on their behalf and get their permission for you to share their contact details with us. We may need these if the application is successful in order to process their award.
